o nameravanem podpisu Tehničnega dogovora o zagotavljanju podpore države  
gostiteljice na zdravstveni vaji Vigorous Warrior 2019 v Romuniji**

Večnacionalna vaja Vigorous Warrior 2019, ki bo v aprilu 2019 potekala v Romuniji, je namenjena povišanju stopnje usposobljenosti in povezljivosti za izvajanje zdravstvene podpore v združenih večnacionalnih operacijah. Na njej bo sodelovalo 30 držav članic Nata in Partnerstva za mir, med njimi vse članice Balkanskih zdravstvenih namenskih sil (BMTF), kjer sodeluje tudi Slovenija. Eden od pomembnejših namenov vaje je tudi usposabljanje BMTF, ki naj bi zagotavljala zdravstveno oskrbo ob naravnih in drugih nesrečah ter v mednarodnih operacijah in misijah.

Vajo organizira Natov center odličnosti za vojaštvo zdravstvo s sedežem na Madžarskem, na njej pa bo iz Slovenije sodelovalo do 17 pripadnikov Slovenske vojske z reševalnim vozilom.

Tehnični dogovor ureja pravice in obveznosti udeleženih strani pri izvajaju aktivnosti, logistično podporo države gostiteljice, določbe glede reševanja odškodninskih zahtevkov, finančna vprašanja in druge vidike sodelovanja na vaji.

**PART ONE**

**GENERAL**

1.1. Purpose and Scope

The purpose of this Technical Arrangement (TA) is to identify the responsibilities and general principles concerning the conduct of the Medical Exercise “VIGOROUS WARRIOR 2019” and the provision of Host Nation Support (HNS). The TA will also describe the standards, type, level, and methods of support of HNS.

1.2. Definitions:

(1) For the purpose of the TA the following definitions will apply:

Exercise:	VIGOROUS WARRIOR 2019
Receiving Participant (RP):	The Ministry of National Defence of Romania (ROU MoND) and the Ministry of Internal Affairs on behalf of the Government of Romania

**Receiving Forces (RF):** The Armed Forces elements of the RP, which will coordinate and provide Host Nation Support on ROU territory, for the participating forces in the exercise

**Sending Participants (SP):** The Participants other than the Ministry of National Defense of Romania and the Ministry of Internal Affairs of Romania.

**Sending Forces (SF):** The Armed Forces of the SP, Headquarters or its elements deploying on the Romanian territory and participating in the exercise.

### 1.3. Reference

Reference documents that may be applicable to the TA are contained at Annex B.

### 1.4. Situation

The Exercise is a multilateral common Medical Live Field Exercise (LIVEX) developed and conceptualized by the NATO Centre of Excellence for Military Medicine (MILMED COE) and will be organized on the military training areas CINCU, CAMPIA TURZII, BUCHAREST and CONSTANTA in the territory of Romania. Details of the exercise area, timeframe and number of participating personnel will be laid down in the EXPLAN.

### 1.5. HNS Mission

The RP will activate its logistics infrastructure to undertake all actions necessary to receive, sustain, and redeploy the SF participating in the Exercise, according to agreed SORs.

### 1.6. Execution

(1) **HNS planning phase:**

- a. The TA will be followed by the SF SOR, which will detail its requirements and will be approved by the RF supporting units and SF receiving support.

- b. The POC for the execution of HNS related to the Exercise will be responsible for the coordination of SOR flow. The SOR stages of HNS planning process will involve other RP military supporting units and agencies and – if necessary – governmental organizations, other civilian agencies and contractors.
- c. The SF and the RF will conduct site surveys, working meetings and establish the SOR for the Exercise. These site surveys will provide a forum to discuss acquisition methodology for goods and services, financial responsibilities, payment procedures and other aspects.
- d. The SF will be responsible for identifying and providing its force protection requirements to the RF. The RF will inform the SF of its proposed force protection measures and restrictions.

**(2) HNS execution phase:**

- a. The HNS during the Exercise and the preparatory phases will be rendered in accordance with the TA.
- b. The RF will provide all possible assistance for the provision of HNS within limits established by other arrangements. The availability of such support will be clarified in the SOR.

**1.7. Command and Control (C2)**

The C2 structure will be contained in the EXPLAN for the Exercise. Based on the current needs the RF military supporting units will establish the Real Life Support Team (RLST) within the exercise locations.

**1.8. Responsibilities**

**1.8.1. Responsibilities of the RF**

- (1) The RF will provide the required logistic support and services as decided by the Participants, taking into account national requirements in SORs and actual availability.
- (2) The standard of goods and quality of service provided by the RF will be in accordance with the details set out in documents supporting the TA and any supplemental arrangements to the TA.

**(3) The RF will:**

- take all necessary measures to facilitate the conduct of the Exercise;
- keep the administrative and financial records necessary to establish reimbursement to the RF for the resources provided to the SF and audit as necessary;
- provide the SF with copies of any environmental regulations, which will apply for the Exercise as well as any regulations in respect of storage, movement, or disposal of hazardous materials or munitions;
- co-ordinate HNS including site surveys, further developing of the detailed HNS concept and the development and execution of the SOR;

- organize, support and participate in joint site surveys;
- take the necessary measures to facilitate the use of airport facilities, border crossing points (BXP), roads, railroads, areas and infrastructure in order to ensure entry/departure, reception, temporary staging and deployment/redeployment of the SF;
- provide facilities and services as outlined in the SOR in accordance with the provisions of the TA.

The Romanian non-governmental organizations involved in the Exercise VIGOROUS WARRIOR 2019 will act under the full responsibility and coordination of the Ministry of Internal Affairs of Romania. The Romanian non-governmental organizations participation is entirely self funded and self sustained.

#### 1.8.2. Responsibilities of the SF

The SF will:

- identify and submit HNS requirements for its participation through the site-surveys and SOR ;
- report to the RF any changes in HNS requirements as they occur and will submit HNS requirements and/or status reports as required;
- comply with RF prerequisite provisions for receiving HNS.

The international non-governmental organizations invited by MILMED COE to participate in the Exercise VIGOROUS WARRIOR 2019 will act under the full responsibility and coordination of MILMED COE. The international non-governmental organizations participation is entirely self funded and self sustained.

## PART TWO

### FINANCIAL PROCEDURES

#### 2.1 General

- (1) Reimbursement for Supplies and Services. The concerned SF will reimburse the RF for all supplies and services rendered by the RF, except those supplies and services, which are provided at no cost or on loan. Reimbursable support and services will be specifically detailed in the TA, or will be detailed in other individual orders for supplies or services.
- (2) Financial and Budget Arrangements. All invoices will be issued in the HN currency. Detailed financial and budget arrangements will be specified for each SOR or individual order for supplies or services. All accounts will be settled in accordance with the provisions established in the TA.
- (3) Loaned Equipment. Any equipment loaned to the SF will be returned by the last day of the Exercise, prior to redeployment. Damaged loaned items will be reported to the RF at the time of return at which time reimbursement as appropriate for repair or replacement will be

negotiated. Cost arising from the use of loaned equipment (e.g. Petroleum, Oil and Lubricants (POL) for vehicles or generators) will be borne by the corresponding borrower.

## **2.2 Cost Formulas**

**Shared Costs.** Incremental costs of resources provided for use by the SF at a location will be recovered on a pro-rata basis. In order to calculate those costs attributable to the deployment of the SF, but which are not covered elsewhere in this section, it will be necessary to identify those shared cost categories in which such additional costs may arise. Following this, for each relevant category, the RF and the SF will agree the proportion of the costs identified, which can be considered as additional by one of the following methods:

- (1) **Personnel Related.** If SF personnel cause additional costs which are directly related to the total personnel occupancy of the base/installation, such costs for the RF will be reimbursed by the SF on a proportional basis as negotiated in individual SOR.
- (2) **Equipment or Task Related.** Where additional costs will be caused by extra equipment (aircraft or other major equipment) required for the SF, or the extension of the normal base operating hours to accommodate the Exercise tasks, then such incremental costs will be reimbursed by the SF on a pro-rata basis in accordance with the number of major equipment/aircraft and or the extension of such operating hours as are individually negotiated in the relevant SOR.

## **2.3 Payment and Reimbursement Procedures**

- (1) Equipment, services and facilities available from military sources on RP military air stations, army bases or military naval installations will be provided free of charge where possible.
- (2) All costs incurred for the provision of services by the RP, that are not free of charge will be determined in accordance with the laws, regulations and cost rates valid on the territory of Romania at the time the services are provided. Invoices will be paid by the SF. The SF will settle these invoices not later than sixty days after receipt via bank transfer to the RF to the bank designated in the invoice and quoting the reference. Bank charges will be borne by the SF.
- (3) The RF will be responsible for documentation of expenses obtained on behalf of the SF.
- (4) Should the SF cancel its participation in the exercise, after the RF has expended funds to furnish the support agreed in a SOR, the SF will be responsible to reimburse the RF for these costs.

## **2.4 Medical Arrangements**

- (1) Emergency medical treatment, including emergency dental care provided by the RF's medical services and evacuation by military transport, including helicopters, will be free of charge. Where assistance is required from the RF to transfer injured personnel to a hospital of the SF's choice using RF assets, the SF will accept responsibility for any reimbursement required for the transportation costs involved.
- (2) In the event of emergency medical evacuation or transportation of injured personnel to

MEDICAL EXERCISE VIGOROUS WARRIOR 2019 ON ROMANIAN TERRITORY**

a civilian hospital using assets other than the dedicated military evacuation system, the SF will reimburse the commercial provider directly for all transportation cost without any RF involvement. The SF will also pay directly the commercial provider for medical care extended to its personnel at local civilian facilities. STRATEVAC will be a SP responsibility.

(3) The SF may take advantage of the provisions of any international or bilateral agreements or arrangements on medical/social security to defray costs of treatment in the territory of Romania.

(4) SF personnel will be afforded comprehensive emergency medical and emergency dental care within capabilities available in the local area. SF personnel will have access to necessary medical and dental emergency treatment from the Medical and Dental Service of the RF under the same conditions as the military personnel of that nation, unless otherwise mutually decided by the RP and the SP.

## **2.5 Contractual Guidelines**

(1) The SF will be authorized to contract directly for commercial-provided goods and services, and will normally have the primary responsibility for the execution of such contracts/purchases.

(2) The RF will facilitate the contracting/purchase of goods and services required by the SF. There will be a designated contracting POC provided by RF who will recommend vendors and assist in the preparation of contracts to facilitate purchases, and to serve as an interface between civilian vendors and the SF contracting/purchasing authorities. The RF will not enter into any financial agreements without the previous consent of the SF.

(3) Details of required goods and services are to be provided by contract/purchase along with providing vendors, method and time of receipt, POC and methods of reimbursement will be detailed in the SOR.

(4) Goods and services provided by the RF to the SF on a reimbursable basis will be documented in the SOR and will not require an additional contract.

## PART THREE

### LEGAL ASPECTS AND OTHER RESPONSIBILITIES

#### **3.1 Legal Status and Claims**

The status of SF personnel deployed on the territory of Romania with the purpose of participating in the Exercise, including activities directly related to the pre-exercise deployment and post exercise redeployment as well as the settlements of non-contractual claims will be determined in accordance with the Agreement between the Parties to the North Atlantic Treaty regarding the Status of their Forces (NATO SOFA), done in London, dated 19 June 1951 or the Agreement among the States Parties to the North Atlantic Treaty and the other States Participating in the Partnership for Peace

regarding the Status of Their Forces and its additional protocol (NATO/PfP SOFA), done in Brussels on 19 June 1995, as the case may be.

3.2. Whenever an infringement of the Romanian law has been committed by a member of the SF, the SF notifies the RP in a timely manner. A template for notification is provided at Annex D.

**3.3 Entry into the Territory of Romania**

SF will apply through normal diplomatic channels to receive permission to enter into the national territory of Romania, not later than 15 working days prior to the planned deployment. SF will request at the same time in an attachment the needed support for the deployment and redeployment phases.

**3.4 Carriage of Arms**

Pursuant to the RP consent and applicable agreements SF personnel may possess and carry the associated weapons and ammunition, on the condition that they are authorized to do so by their orders and insofar as this is indispensable for the official purpose of their stay.

**3.5 Force Protection (FP)**

Comprehensive and effective FP will be detailed in the OPLAN or supplementary arrangements.

**3.6 Environmental Protection (EP)**

The RF will provide the SF with copies of environmental compliance rules or standards, which will apply during the course of the Exercise. The standards will be no higher than those under which the RF will operate. The SF will comply with environmental standards valid on the territory of Romania. With regard to the transport of dangerous goods or medical or biological hazardous samples the STANAG 4441 will be observed. Damage caused by failure to comply with the standards so notified will be remedied by the Participant causing the damage or possible claims will be settled in accordance with the applicable agreements. Comprehensive and effective EP will be detailed in the EXPLAN or supplementary arrangements.

**3.6 Flight Safety**

- (1) If a military aircraft of the SF is involved in a crash, the military police authorities of the RP will secure the crash site.
- (2) Incidents and accidents that may occur during flight missions shall be investigated in accordance with applicable international agreements and national legislations of the Parties.
- (3) Any air accident or incident involving assets provided under the TA will be subject to an investigation. The investigation report will be handed over to the concerned SF.

**3.7 Security and Protection of Information**

- (1) All classified information or material exchanged or generated under the provisions of the TA will be used, handled, transmitted and safeguarded in accordance with the Participants' national security laws and regulations, and applicable agreements.
- (2) Each Participant will take all lawful steps available to it to keep free from disclosure all information exchanged in confidence, unless the other Participant will consent to such disclosure.

**3.8 RP will provide work safety advices and, if work accidents occurs, are to be investigated by RP in accordance with Romanian law.**

**PART FOUR**

**SUPPLIES AND SERVICES**

**4. HNS Requirements Overview**

- (1) Specific HNS requirements will be detailed in the SOR.
- (2) The RF may provide the SF with assistance from civilian organizations in Romania during the Exercise if required.
- (3) The RF will offer to the SF the following supplies and services free of charge during the Exercise
  - a. use of all identified military facilities and areas for Exercise-related purposes in accordance with the SOR. All buildings and real estate will be handed over to the SF in a safe and clear condition; the SF will return buildings to the RF in the same and clear condition;
  - b. assistance by military and administration personnel of RF assigned to the Exercise;
  - c. access to the existing military signal system;
  - d. military loading and unloading equipment and its operating personnel upon arrival and departure, and ground equipment during the exercise (excluding POL consumption);
  - e. use of military transportation assets (excluding POL consumption);
  - f. existing internal military communication and Automatic Data Process (ADP) systems, in accordance with the requirements of the Exercise;
  - g. space for the storage of materiel in military facilities;
  - h. maintenance and repair work on material and equipment in military facilities (excluding incremental costs);
  - i. military maps;
  - j. access to/utilization of rest and recreation military facilities (athletic areas, social facilities, etc.).
- (4) Upon request, the RF will provide, arrange or co-ordinate the provision of the following supplies and services on a cost reimbursement basis during the execution of the Exercise:

- a. common messing in RF facilities (cash payment at the messing facility);
- b. accommodation in military facilities (incremental costs only); accommodation and its cost will be specified in the SOR;
- c. rental or lease of civil communication equipment/systems;
- d. industrial gas and compressed air;
- e. non-military vehicles included in the SOR;
- f. POL products;
- g. provision of catering staff, food and beverages for official functions;
- h. hire of temporary civilian personnel;
- i. postal services;
- j. medical treatment other than provided by the RP under 2.4 (1);
- k. other supplies and services as requested in the SOR.

**PART FIVE**

**FINAL PROVISIONS**

5. Final Provisions

- (1) This TA shall become effective on the date of the signature of minimum 5 participating nations. The Host Nation will inform the participants in this TA in regard of the signature process progress. It will remain in effect until all outstanding issues concerning the Exercise have been settled. Nations who are not SP to the TA will be invited to accept its provisions by either a Note of Accession (NOA) or a Statement of Intent (SOI) as attached in Annex C. For these additional Participants the TA will be applied from the date of their respective NOA / SOI signatures.
- (2) The TA may be revised or amended in writing at any time by mutual consent between the Participants.
- (3) Any dispute concerning the interpretation and application of the TA will be solely settled amicably by negotiation and consultation between the Participants concerned at the lowest possible level and will not be referred to any national or international tribunal or third party for settlement.
- (4) The TA does not create any rights or obligations under international law that do not already exist pursuant to international agreements between the States of the Participants. It is neither intended to conflict with the Participants' respective national law, nor is it intended to conflict with, expand upon or replace applicable international agreements and the obligations and authorities therein. Should such a conflict arise, the Participants will notify each other, and the provision of national law and international law will prevail.
- (5) The TA will be signed in one version in the English language. It will be kept with the RP, which will transmit a copy thereof to the Participants.

## PRVI DEL

### SPLOŠNO

#### 1.1. Namen in obseg

Namen tega tehničnega dogovora (TD) je opredeliti pravice in obveznosti ter splošna načela za izvedbo zdravstvene vaje Vigorous Warrior 2019 in za zagotovitev podpore države gostiteljice (PDG). TD bo prav tako opredelil standarde, tipe, nivo in metode PDG.

#### 1.2. Opredelitev pojmov:

(1) V tem TD imajo uporabljeni izrazi naslednji pomen:

Vaja: VIGOROUS WARRIOR 2019

Udeleženec sprejemnik: Ministrstvo za nacionalno obrambo Romunije in Ministrstvo za notranje zadeve v imenu Romunske Vlade.

Sprejemne sile: Oborožene sile udeleženke sprejemnice, ki bodo koordinirale in zagotavljale PDG na ozemlju Romunije za gostujoče sile na vaji.

1.4. Situacija

Vaja je večnacionalna skupna zdravstvena terenska vaja (LIVEX), ki jo je razvil in zasnoval Nato Center odličnosti za vojaško zdravstvo (NATO Centre of Excellence for Military medicine - MILMED COE) in se bo izvedla na vojaških vadiščih CINCU, CAMPIA TURZII, BUCHAREST in CONSTANTA na ozemlju Romunije. Natančnejše določbe glede območja vaje, časovnice in števila pripadnikov udeležencev bodo opredeljene v Načrtu vaje (EXPLAN).

1.5. Naloga in cilj PDG

Udeleženec sprejemnik aktivira svojo logistično infrastrukturo za izvedbo vseh ukrepov glede sprejema in namestitve, oskrbovanja ter odhoda gostujočih sil, skladno z dogovorjenimi Izjavami o potrebah (SOR).

1.6. Izvedba

(1) Faza načrtovanja PDG:

- a. Temu TD bodo sledile Izjave o potrebah (SOR) gostujočih sil, v katerih bodo natančno opredeljene zahteve za PDG, ki jih bodo odobrile podporne enote sprejemnih sil in gostujočih sil, ki bodo sprejele podporo.
- b. Osebe za stike za zagotovitev PDG za vajo, bodo odgovorne za usklajevanje SOR. V pripravo in usklajevanje SOR bodo v procesu načrtovanja PDG vključene tudi druge vojaške podporne enote in agencije sprejemne sile in - po potrebi - tudi vladne organizacije, druge civilne agencije in pogodbeniki.
- c. Gostujoče in sprejemne sile bodo izvedle oglede prizorišč vaje, delovne sestanke in oblikovale SOR za vajo. Ogledi prizorišč zagotavljajo forum za razpravo o metodologiji pridobivanja blaga in storitev, finančnih obveznostih, plačilnih postopkih in drugih vidikih.
- d. Gostujoče sile so same odgovorne, da sprejemnim silam posredujejo svoje zahteve glede zaščite sil. Sprejemne sile obvestijo gostujoče sile o svojih predlaganih ukrepih in omejitvah glede zaščite sil.

(2) Faza izvedbe PDG:

- a. PDG med vajo in v pripravljalni fazi se bo izvajala v skladu s TD.
- b. Sprejemne sile nudijo vso potrebno pomoč za zagotovitev PDG v okviru omejitev, določenih z drugimi dogovori. Razpoložljivost take podpore se navede v SOR.

1.7. Poveljevanje in kontrola

Struktura poveljevanja in kontrole bo opredeljena v Načrtu za vajo. Na temelju izraženih potreb bodo vojaške podporne enote sprejemnih sil na lokacijah vaje ustanovile podporne enote za zagotavljanje PDG (Real Life Support Units – RLST).

## 1.8. Obveznosti in odgovornosti

### 1.8.1. Sprejemne sile

(1) Sprejemne sile bodo zagotovile z udeleženci dogovorjeno logistično podporo in usluge, upoštevajoč pri tem nacionalne zahteve iz SOR in dejansko razpoložljivost.

(2) Standard blaga in kvaliteta storitev, ki jih bodo zagotavljale sprejemne sile, bo v skladu s podrobnostmi, določenimi v dokumentih, ki podpirajo TD, in drugimi dodatnimi dogovori k TD.

(3) Sprejemne sile bodo:

- upoštevale predpogoje sprejemnih sil za zagotovitev PDG.

Mednarodne nevladne organizacije, ki jih je Center odličnosti za vojaško zdravstvo (MILMED COE) povabil, da sodelujejo na vaji Vigorous Warrior 2019, bodo delovale pod polno odgovornostjo in usklajevanjem MILMED COE. Sodelovanje mednarodnih nevladnih organizacij je v celoti samostojno financirano in samozadostno.

## FINANČNI POSTOPKI

### 2.1. Splošno

(1) Povračilo stroškov za dobave in storitve. Zadevna gostujoča sila bo povrnila sprejemnim silam stroške za vse dobave in storitve, ki jih izvedejo slednje, razen za dobave in storitve, ki bodo zagotovljene brezplačno ali z izposojo. Podpora in storitev, za katere bo potrebno povrniti stroške, bo opredeljena v TD ali v drugih individualnih naročilih za blago ali storitev.

(2) Finančne in proračunske ureditve. Vsi računi bodo izdani v valuti države gostiteljice. Podrobne finančne in proračunske ureditve bodo določene za vsak SOR ali posamezno naročilo blaga ali storitev. Vsi računi bodo poravnani v skladu z določbami, določenimi v TD.

(3) Izposojena oprema. Gostujoče sile vrnejo vso izposojeno opremo do zadnjega dne vaje oziroma pred odhodom sil. O izposojenih predmetih, ki so bili poškodovani med vajo, se poroča sprejemnim silam pred odhodom z vaje in se dogovori o povračilu stroškov, ustreznih za popravilo ali zamenjavo te opreme / predmetov. Stroške, ki nastanejo zaradi uporabe najete opreme (npr. nafta, olja in maziva (POL) za vozila ali generatorje), nosi zadevni posojilojemalec.

Za izračun stroškov, ki jih bo mogoče pripisati gostujočim silam, ki pa niso zajeti drugje v tem delu TD, je treba opredeliti tiste kategorije skupnih stroškov, v katerih se lahko pojavi takšni dodatni stroški. V skladu z navedenim, se bodo sprejemne in gostujoče sile dogovorile, za vsako zadevno kategorijo, o deležu ugotovljenih stroškov, ki se lahko štejejo za dodatne, na enega od naslednjih načinov:

(1) Osebje. Če osebje gostujočih sil povzroči dodatne stroške, ki so neposredno povezani s celotno obremenjenosti osebja baze / namestitve, bodo gostujoče sile te stroške povrnile sprejemnim silam na sorazmerni osnovi, kot bo dogovorjeno v posameznih SOR.

(2) Oprema ali povezana naloga. Če bodo dodatni stroški nastali zaradi dodatne opreme (zrakoplova ali druge pomembne opreme), ki jo bodo zahtevali gostujoče sile, ali zaradi podaljšanja običajnih ur delovanja baze za izpolnitve nalog povezanih z vajo, bodo gostujoče sile take dodatne stroške povrnile sorazmerno glede na število zagotovljene glavne opreme / letala in / ali podaljšanje obratovalnih ur, kot je individualno dogovorjeno s SOR.

### 2.3 Postopki plačil in povračil

(1) Oprema, storitve in objekti, ki so zagotovljeni iz vojaških virov na vojaških letališčih sprejemnih sil, vojaških bazah ali vojaških mornariških oporiščih, bodo zagotovljeni brezplačno, kjer je to mogoče.

(2) Vsi stroški, ki nastanejo zaradi zagotavljanja storitev s strani sprejemnih sil in jih je potrebno povrniti, bodo določeni v skladu z zakoni, predpisi in višino stroškov, ki veljajo na ozemlju Romunije v času zagotovitve storitev. Gostujoče sile bodo poravnale račune. Gostujoče sile bodo te račune poravnale najkasneje v šestdesetih dneh po prejemu računa z bančnim nakazilom na banko gostujočih sil, ki je navedena v računu, in navedle sklic. Bančne stroške krijejo gostujoče sile.

(3) Sprejemne sile bodo odgovorne za dokumentiranje stroškov, nastalih gostujočim silam.

(4) V kolikor bo gostujoča sila odpovedala udeležbo na vaji potem, ko so sprejemne sile porabile

sredstva za zagotovitev podpore dogovorjene v SOR, bo gostujoča sila povrnila nastale stroške sprememnim silam.

#### 2.4 Medicinske ureditve

(1) Nujna medicinska pomoč, vključno z nujno zobozdravstveno oskrbo, ki jo zagotavljajo zdravstvene službe sprememnih sil, in evakuacija z vojaškimi prevozi, vključno s helikopterji, bo brezplačna. Kadar gostujoča sila potrebuje sredstva in pomoč sprememnih sil za prevoz svojega poškodovanega osebja v bolnišnico, ki jo izbere gostujoča sila, bo gostujoča sila tudi povrnila stroške takšnega prevoza.

(2) V primeru nujne medicinske evakuacije ali prevoza poškodovanega osebja v civilno bolnišnico s sredstvi, ki ne spadajo v namenski vojaški evakuacijski sistem, bo gostujoča sila neposredno, brez pomoči sprememnih sil, povrnila komercialnemu ponudniku vse stroške prevoza. Gostujoča sila bo prav tako neposredno povrnila stroške komercialnemu ponudniku za zdravstveno oskrbo v lokalnih civilnih objektih. Strateška evakuacija (STRATEVAC) je odgovornost gostujočih sil.

(3) Gostujoče sile lahko koristijo določbe vseh veljavnih mednarodnih ali dvostranskih sporazumov ali dogovorov o zdravstvenem / socialnem zavarovanju za kritje stroškov zdravljenja na ozemlju Romunije.

(4) Osebju gostujočih sil bo zagotovljena celovita nujna medicinska in nujna zobozdravstvena oskrba v okviru razpoložljivih zmogljivosti na lokalnem območju vaje. Osebje gostujočih sil bo imelo dostop do nujne medicinske in zobozdravstvene nujne oskrbe, ki bo zagotavljala in izvajala Medicinska in zobozdravstvena služba sprememnih sil pod enakimi pogoji kot vojaško osebje sprememnih sil, razen, če se bodo sprememne sile in gostujoče sile medsebojno drugače dogovorile.

#### 2.5. Pogodbene smernice

(1) Gostujoče sile lahko neposredno sklepajo pogodbe za komercialno dobavo blaga in storitev in imajo običajno prvenstveno odgovornost za izvedbo takih pogodb/nabav.

(2) Na izraženo zahtevo lahko sprememne sile nudijo pomoč pri sklenitvi pogodbe/nakupu blaga in storitev, ki jih potrebujejo gostujoče sile. Sprejemne sile določijo osebo za stike glede sklepanja pogodb, ki lahko priporoči ponudnike in pomaga pri pripravi pogodb za lažje izvedbe nabav in je posrednik med civilnimi pogodbeniki in organi za sklepanje pogodb / nakupov gostujočih sil. Sprejemne sile ne bodo sklepale nobenega finančnega dogovora brez predhodnega soglasja gostujočih sil.

(3) Podrobnosti glede blaga in storitev, ki naj se zagotovijo s pogodbo/nabavo, skupaj z dobavitelji, načinom in rokom prejema, osebo za stike in načinom finančnega povračila, se določijo v SOR.

(4) Blago in storitve, ki jih sprememne sile zagotavljajo gostujočim silam na temelju finančnega povračila, se dokumentirajo v SOR in ne potrebujejo dodatne pogodbe.

### TRETJI DEL

#### PRAVNI VIDIKI IN DRUGE ODGOVORNOSTI

##### 3.1. Pravni status in odškodninska odgovornost

Pravni status osebja gostujočih sil, ki je razmeščeno na ozemlju Romunije z namenom udeležbe na vaji, vključno z dejavnostmi, ki so neposredno povezane s prihodom in pripravami na vajo ter odhodom z vaje in poravnavo ne-pogodbenih odškodninskih zahtevkov, ureja Sporazum med pogodbenicami Severnoatlantske pogodbe o statusu njihovih sil (Nato Sofa), podpisani v Londonu 19. junija 1951, ali pa Sporazum med državami pogodbenicami Severnoatlantske pogodbe in drugimi državami, ki sodelujejo v Partnerstvu za mir glede statusa njihovih sil in dodatnega protokola (Nato / PzM Sofa), podpisani v Bruslju 19. junija 1995, odvisno od primera.

3.2. Kadar pripadnik osebja gostujočih sil krši romunsko pravo, o tem gostujoča sila pravočasno obvesti sprejemne sile. Predloga za priglasitev je priložena v Prilogi D.

### 3.3. Vstop na ozemlje Romunije

Gostujoče sile po običajnih diplomatskih poteh posredujejo zahtevke za pridobitev dovoljenja za vstop na nacionalno ozemlje Romunije najkasneje 15 delovnih dni pred načrtovano napotitvijo. Istočasno gostujoče sile podajo zahtevke za potrebno podporo v fazi prihoda in razmestitve ter izstopa oziroma odhoda.

### 3.4 Prevoz orožja

V skladu s soglasjem udeleženca sprejemnika in veljavnimi sporazumi lahko pripadniki gostujočih sil posedujejo in nosijo orožje in strelivo, pod pogojem, da so za to pooblaščeni s svojim ukazom za delovanje na vaji in v kolikor je to nujno za uradni namen njihovega bivanja.

### 3.5 Zaščita sil

Celovita in učinkovita zaščita sil bo podrobno določena v Operativnem načrtu za vajo (OPLAN) ali dodatnih dogovorih.

### 3.6 Varstvo okolja

Sprejemne sile zagotovijo gostujočim silam kopije okoljskih predpisov ali standardov, ki veljajo med potekom vaje. Standardi niso strožji od standardov, ki veljajo za delovanje sprejemnih sil. Gostujoče sile morajo spoštovati veljavne okoljske standarde na ozemlju Romunije. V zvezi s prevozom nevarnega blaga ali medicinskih ali bioloških nevarnih vzorcev, bodo upoštevane določbe STANAG 4441. Udeleženec, ki bi zaradi neupoštevanja tako priglašenih standardov povzročil škodo, škodo odpravi, ali pa bodo zoper njega podani odškodninski zahtevki v skladu z veljavnimi sporazumi. Celovito in učinkovito varstvo okolja bo podrobno opredeljeno v Načrtu za vajo (EXPLAN) ali dodatnih dogovorih.

### 3.6 Varnost letenja

(1) Če bo vojaški zrakoplov gostujoče sile udeležen v nesreči, bodo organi vojaške policije sprejemnih sil zavarovali mesto nesreče.

(2) Incidenti in nesreče, ki se lahko pojavijo med nalogami letenja, se preiskujejo v skladu z veljavnimi mednarodnimi sporazumi in nacionalnimi zakonodajami udeležencev.

(3) Vsaka letalska nesreča ali incident, ki vključuje sredstva, zagotovljena skladno s TD, bo predmet preiskave. Poročilo o preiskavi bo izročeno zadevnim gostujočim silam.

### 3.7 Varnost in zaščita informacij

(1) Vsi tajni podatki ali gradivo, ki bodo izmenjani ali ustvarjeni v skladu z določbami tega TD, se bodo uporabljali, obravnavali, posredovali in varovali v skladu z nacionalnimi zakoni in predpisi o varnosti gostujočih sil, in veljavnimi sporazumi.

(2) Vsak udeleženec bo sprejel vse zakonite ukrepe, ki so mu na voljo, da ne bo razkril zaupnih informacij, ki bodo izmenjane, razen če bo drug udeleženec privolil v takšno razkritje.

3.8 Udeleženec sprejemnik bo zagotovil navodila za varnost pri delu in, bo v primeru povzročene nesreče pri delu to raziskal v skladu z romunskim pravom.

(4) TD ne ustvarja dodatnih pravic ali obveznosti po mednarodnem pravu, ki še ne obstajajo v skladu z mednarodnimi sporazumi med državami udeleženkami. Namen TD je spoštovati in upoštevati veljavne predpise udeležencev in mednarodne sporazume, ki veljajo med udeležencema.
